- summer/winter school:** Ein Teilnahmezertifikat unter Angabe des Teilnahmeerfolges und der Stunden ist mit einzureichen. Diese Kurse müssen ausgewiesene Weiterbildungsmaßnahmen (nicht z.B. Workshops im Rahmen einer Tagung) sein und von einer anerkannten Institution angeboten werden.

These courses must be designated further training measures (not f.e. workshops as part of a conference) and to be offered by a recognized institution.*
